

LIMITATIONS

- -No minors permitted on the premises unless the minor is a qualifying patient under the Compassionate Use of Medical Cannabis Pilot Program Act.
- -Distribution to persons under the age of 21 is prohibited.
- -Transportation of cannabis or cannabis products across state lines is prohibited.
- -The effects of cannabis products can vary from person to person, and can take as long as two hours to feel the effects of some cannabisinfused products. Carefully review the portion size information and warning contained on the packaging before consuming.
- -Cannabis consumption can impair cognition and driving, is for adult use only, may be habit forming, and should not be used by pregnant or breastfeeding women.
- -Edible cannabis-infused products were produced in a kitchen that may also process common food allergens.



COMMON QUESTIONS

Can I grow my own?

Only Registered Qualifying Illinois Medical Cannabis Patients may grow cannabis at home.

<u>I have an out-of-state medical cannabis card, am I allowed to use it in Illinois?</u>

No, Illinois does not recognize any out-of-state cardholders however, you are welcome to shop with us as a Recreational consumer as long as you are age 21 or older.

How often can I visit the dispensary?

We prefer that you visit our store 1 time per day. Remember the allowable limits are possession limits that only you can monitor.

Where can I consume cannabis?

Cannabis must be consumed on private property (with permission of the owner) or approved cannabis lounges. It is illegal to consume cannabis near anyone under 21 years of age, in public spaces (including parks, streets, sidewalks), in motor vehicles, or on school grounds.

How is Adult-Use Cannabis Taxed?

Expect total taxes on adult-use cannabis purchases between 25% to 40%. Cannabis flowers or products with a THC content of less than 35% will be taxed 10% by the state while those above that 35% threshold will be taxed at 25%. Cannabis-infused products (such as edibles) will be taxed at 20%. In addition, there is local sales tax for city and county depending on store locality.



ADULT USE INFO

Thrive offers an online menu that showcases our products. For speedy checkout, we encourage everyone to utilize this online feature at **www.thriveil.com**. Instructions are at the top of each menu.

Need to make changes to your order? No worries, nothing is final until you come into the store for payment and pickup.

In order to enter the dispensary and make a purchase, you need a government-issued state ID proving you are age 21 or older. IDs must be valid showing expiration date, photo, and address.

In-State Possession Limit (Daily):

30 g - Cannabis Flower
5 g- Cannabis Concentrate
500 mg - THC Cannabis Infused Product (edibles)

Out of State Possession Limit (Daily):

15 g - Cannabis Flower
2.5 g - Cannabis Concentrate
250 mg - THC in Cannabis-Infused Products
(edibles)

An individual may possess a combination of flower, concentrates, and cannabis-infused products up to the limit for each category of product.

Shoppers are allowed 1 visit/day
